

Reporting Against Impact Indicators

As you developed your individual plan of work on the on-line system you were asked to select impact indicators to correspond with learning and action outcomes. Impact indicators are specific and measurable statements that reflect what successfully reaching that outcome would look like. These indicators guide the evaluation plan for the outcome, letting you know what needs to be measured.

Like outputs, when you log into the system to report, all of the impact indicators you have selected will appear to remind you what you are reporting against. You can access this screen by clicking on “Indicators” on the left side of your screen when you log in. (You’ll find this menu under “Reporting”).

Unlike outputs (activities), you aren’t likely to report against impact indicators monthly or even quarterly (although you are welcome to) so you may do this only once or twice a year.

If you're not sure who is responsible for collecting and reporting data for each indicator, please check with your program leader. Each program area (and many times each state specialist) will handle this a bit differently. For example, a specialist may agree to collect and compile data and enter it all in from the state office, by county OR they may send county staff the final data to enter OR you may already have the tool and have collected the data in the county so you can enter it directly.

Data reported against Impact Indicators will comprise the heart of our federal Annual Accomplishment report. CSREES has an entirely new system for states to report into and they are looking for solid, quantitative data that reflects learning and behavior change as a result of Extension programs. In addition, this impact information will be used to develop future state annual reports for our campus partners, legislators, and other stakeholders in New Hampshire.
