## STARTING OVER: NEW CHOICES...NEW DIRECTION

### Personal Financial Management Instructional Course

This two-hour course is presented to New Hampshire bankruptcy filers in order to meet the necessary requirement for personal finance education, as specified by federal bankruptcy law. Upon completion of this course, and submission of a course evaluation form, a certificate of completion will be provided to each participant. UNH Cooperative Extension does not pay or receive fees or other consideration for the referral of debtor students to our course.

Instructors will either be trained Family and Consumer Resource county educators or instructors supervised by these educators. All of the county educators have received training in *Starting Over: New Choices...New Direction* from Suzann Enzian Knight, M.O.E., M.S., CFP, Family Resource Management Specialist and Faculty with University of New Hampshire Cooperative Extension who has been giving instruction and writing publications/curricula on Personal Financial topics for over 20 years.
