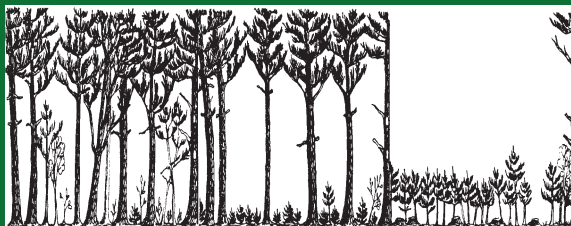

Directions to Fox State Forest:

From the east: Rt. 202/9. Take the Henniker St./W. Main St. Hillsborough exit. Go left at stop sign at end of exit ramp. Go 1.8 miles to traffic light in the center of Hillsborough. Go right onto School Street. Fox Forest is approximately 2 miles on the right.

From the west: Rt. 9. Take the Hillsborough/Peterborough exit. Go right at stop sign at end of exit ramp. Go left at traffic light (by McDonald's). Go 1.4 miles to traffic light in the center of Hillsborough. Go left onto School Street. Fox Forest is approximately 2 miles on the right.

Directions to Annett State Forest, Rindge:

From Hillsborough - Take NH Rt 202 to Peterborough and the junction of NH Rt 101, take a left on NH Rt 101 (east) .9 mi to NH Rt 123, take a right on NH Rt 123 (south) to the junction of NH Rt 124 (6.1 mi), turn right on NH Rt 124 (west) for .2 mi., take a left on Timbertop Road, go 0.6 mi. and take a right on Hubbard Pond Road (which turns into Annett Road at the Rindge town line) the meeting spot is a log landing approximately 1.5 mi. on the left, parking will be on the log landing inside an orange gate.

Pulling the Trigger-Even Aged Silviculture

Even-aged silviculture-we all work in forest types where it works. We thin young even-aged stands. We apply shelterwood cuts to get the regeneration we want. We have landowners who want to "do the right thing for wildlife" including the species which use early successional habitats and young forests. We've all walked into those stands where "it's just time to start over". But when it comes right down to it, "pulling the trigger" and doing that final overstory removal can be hard. Come look at the pros, cons, and the "how to" of seeing even-aged management through to the end of one stand and the start of another.
