



Barry Conservation Camp Pre-Registration & Scholarship Application - APPLY NOW!

DOES YOUR 4-H MEMBER WANT TO GO TO CAMP?

This year Merrimack County 4-H members are guaranteed a spot at Barry Conservation Camp if they pre-register using the [Merrimack County 4-H Foundation Campership Application Form](#). Filling out the application will insure that your 4-H member will have the opportunity to save a spot for their chosen camp session before the general public. The application must be in the Merrimack County 4-H Office **on or before January 24, 2020 at 3:30pm** in order to guarantee your campers spot. Any application received after this date will not be considered for *early camp registration* or *scholarship funds*.

CAMP SCHOLARSHIP AVAILABLE:

Additionally, Merrimack County 4-H Foundation will be awarding financial scholarships to each 4-H youth member that fills out the Campership Application. Scholarship amounts will be determined once we have received all applications and have an idea of how many youths are in need. *If you **do NOT** wish to receive scholarship funds and simply just want to guarantee your 4-H member a spot at Barry Camp, then put \$0.00 in the amount requested section on the application.*

CAMP SCHOLARSHIP FUNDS:

Families will be notified the week of February 3, 2020 as to how much their scholarship will be. Notification will come first by email and then again through the mail. At that point you will know how much you will need beyond your deposit to make the camp experience happen. You may need to apply for [additional scholarship assistance](#) elsewhere to make up the difference needed. The Merrimack County 4-H Foundation Scholarship Funds will be mailed directly to the camp after the family has registered their youth and paid the initial \$50.00 deposit to Barry Conservation Camp.

REGISTERING FOR BARRY CONSERVATION CAMP ONLINE:

You will still need to register your child online with Barry Conservation Camp when registration goes live on February 17, 2020. By February 28th, all pre-registered campers need to enroll using a discount code. The discount code will be provided to you via email prior to Camp Open Enrollment. During the final registration process, you will be prompted to make a deposit. You will need to pay a **\$50.00 deposit to hold your spot.**

At the time of your camp registration, the session *might say* **“Wait List Only.”** You should put your camper on the “Wait List” if there is one. If you are on a “Wait List”, Barry Camp will open up the spot for you and email you an invitation to complete your registration. You will then complete the registration and pay your \$50.00 deposit.
