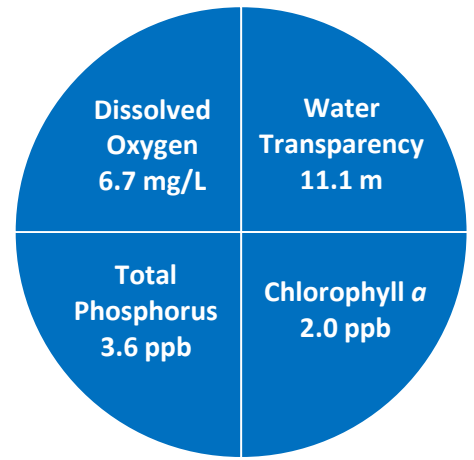


Blue = Oligotrophic

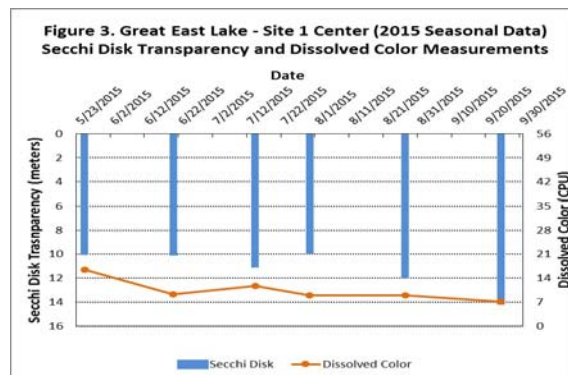
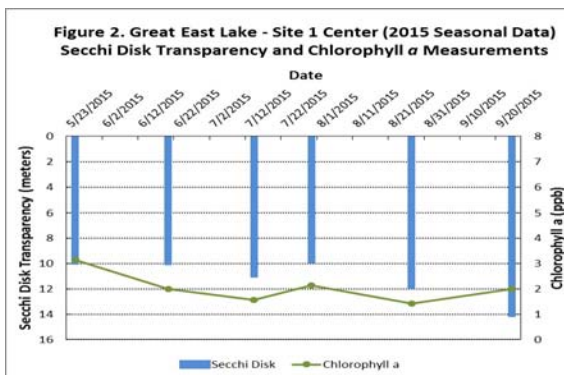


Figure 2 and 3. Seasonal Secchi disk transparency, chlorophyll *a* changes and dissolved color concentrations. Figures 2 and 3 illustrate the interplay among Secchi Disk transparency, chlorophyll *a* and dissolved color. Shallower water transparency measurements oftentimes correspond to increases in chlorophyll *a* and/or color concentrations.

LONG-TERM TRENDS

WATER CLARITY: The Great East Lake water clarity measurements, measured as Secchi Disk transparency, display a trend of increasing water clarity (Figure 4).

CHLOROPHYLL: The Great East Lake chlorophyll *a* concentrations, a measure of microscopic plant life within the lake, display a trend of decreasing concentrations (Figure 4).

TOTAL PHOSPHORUS: Phosphorus is the nutrient most responsible for microscopic plant growth. The Great East Lake total phosphorus concentrations have varied among years (Figure 5). The total phosphorus data do not display a long-term water quality trend.

COLOR: The Great East Lake color data, the result of naturally occurring “tea” color substances from the breakdown of soils and plant materials, have decreased slightly over the past twenty-eight years (Figure 5).

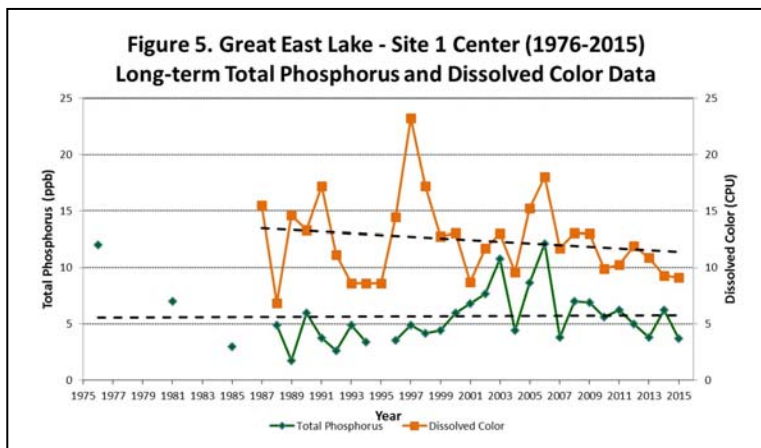
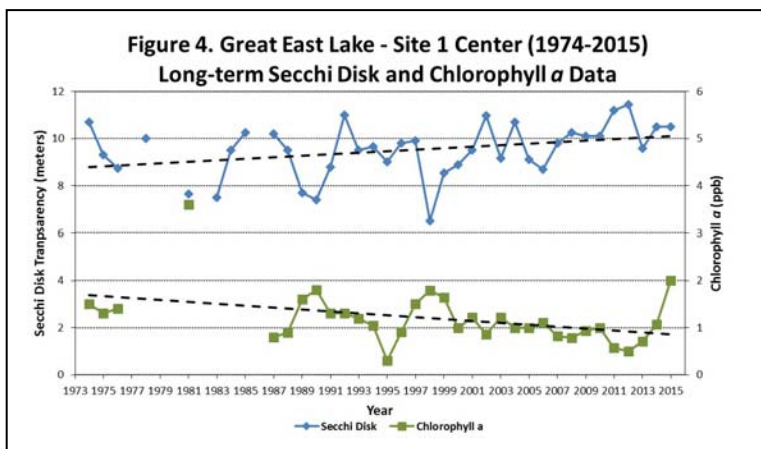


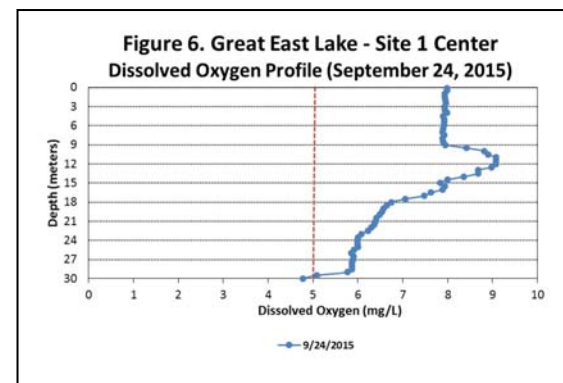

Figures 4 and 5. Changes in the Great East Lake water clarity (Secchi Disk depth), chlorophyll *a*, dissolved color and total phosphorus concentrations measured between 1974 and 2015. **These data illustrate the relationship among plant growth, water color and water clarity. Total phosphorus data are also displayed and are oftentimes correlated with the amount of plant growth.** Trendlines are displayed when sufficient data are available.

Figure 6. Great East Lake dissolved oxygen profile collected on September 24, 2015. The vertical red line indicates the oxygen concentration commonly considered the threshold for successful growth and reproduction of cold water fish such as trout and salmon.



Recommendations

Implement Best Management Practices within the Great East Lake watershed to minimize the adverse impacts of polluted runoff and erosion into the lake. Refer to “Landscaping at the Water’s Edge: An Ecological Approach” and “New Hampshire Homeowner’s Guide to Stormwater Management: Do-It-Yourself Stormwater Solutions for Your Home” for more information on how to reduce nutrient loading caused by overland run-off. The Acton Wakefield Watershed Alliance also offers technical assistance to help design and implement erosion control projects that protect and improve the water quality.

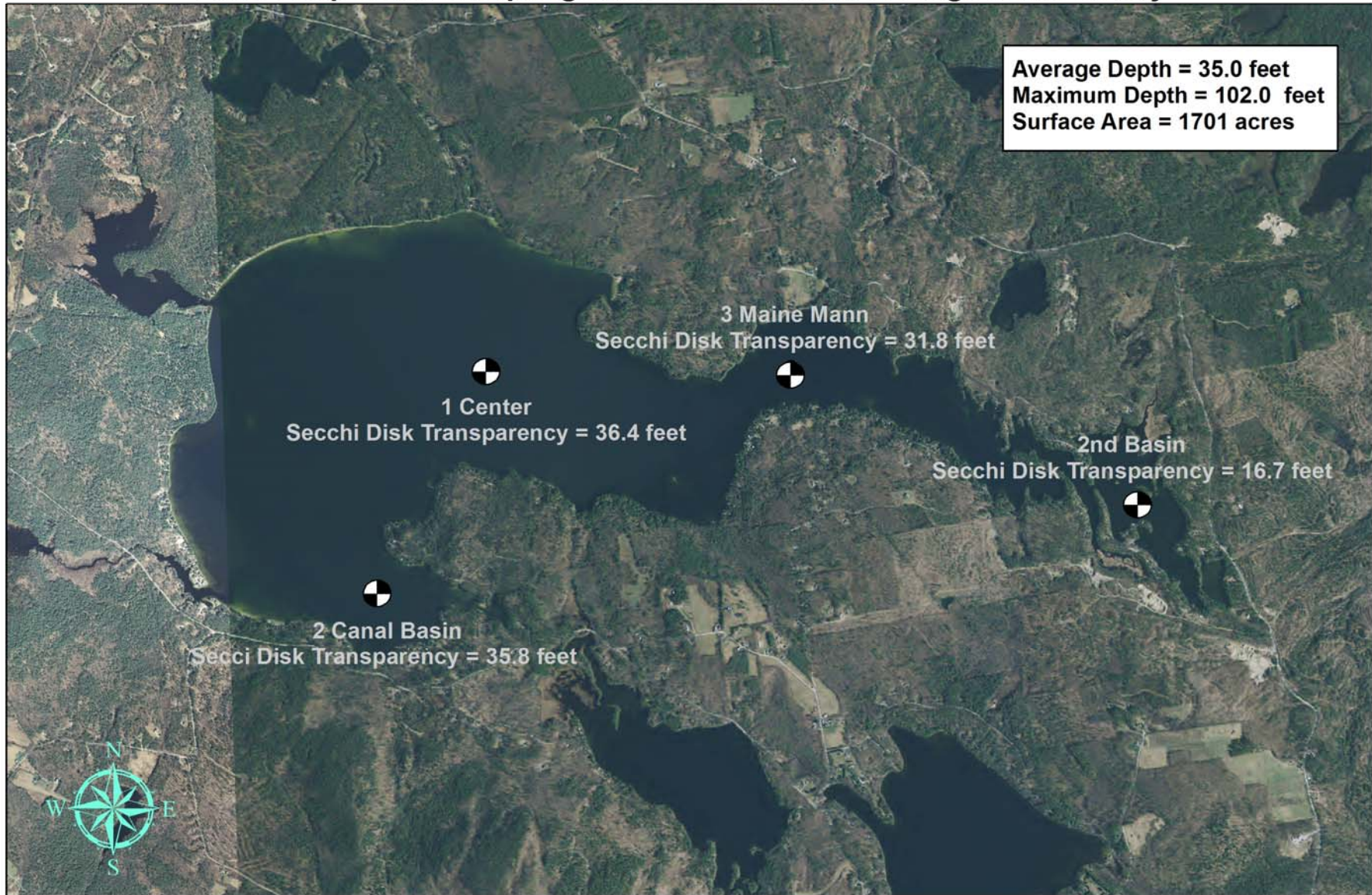
