The 4-H Foundation of New Hampshire funds projects and activities that enhance opportunities available to 4-H members and leaders, increase public awareness of the broad scope of the New Hampshire 4-H youth development program, aid in the recruitment of new audiences who may become engaged in the 4-H youth development program, and support the integration of the 4-H youth development program with the resources available at UNH.

Grants are made possible by unrestricted and designated gifts and endowment income. This application is for programs, events, and activities held between **July 1, 2018 and June 30, 2019.** Funds are not released until after **July 1, 2018**.

Please read carefully before starting the application form. Your grant application may be shared with potential donors to help secure necessary funding. Additional proposals are reviewed throughout the year at regularly scheduled board meetings and funded if they meet the guidelines and funds are available. All foundation board members are not familiar with all aspects of the 4-H youth development program. Your program description helps the board explain project needs to potential donors.

Grant funds will be distributed beginning July 1, 2018 by following UNH fiscal policies: submitting original receipts with appropriate documentation or contacting the 4-H Foundation of NH to purchase items directly.

If income from other sources exceeds budget projections or costs are lower than budgeted, the 4-H Foundation of NH requests that you expend these other sources first, prior to accessing grant dollars.
