



#### Q3 - 1. Do you regularly attend the two educational workshops put on by the NHLTC?





## Q4 - 2. How useful do you find the NHLTC workshops













### Q10 - 7. Do you find the email listserv useful/informative?





Q11 - 8. Have you posted anything on the email listserv or responded to anything that was posted?









Q15 - 11. Should NHLTC develop a peer - peer mentoring program for new land trust staff?





Q16 - 12. Do you feel NHLTC needs to do a coordinated outreach program about land conservation for the general public to encourage more land protection and support for Land Trusts?





Having a presence at statewide events that draw potential conservation easement donors would be beneficial, as would preparing general information for landowners and the general public - general information that could be "plagiarized" by regional land trusts for their web sites... Articles in the Union Leader or other papers when a land trust issue is in the news. Outreach to estate and financial planners, foresters, and other professionals who have contact with potential conservation land owners to promote land conservation, help promote landowner benefits and options.
