RELEASE OF LIABILITY

I, _____, recognize that equestrian activities are a dangerous sport involving a high degree of risk of minor and serious bodily harm, including death, and I hereby assume this risk. I recognize and agree that there are inherent risks in equestrian activities which are virtually impossible for the owners of Paradis Farm to eliminate, including but not limited to: (1) the propensity of equines (horses, ponies, donkeys, mules) to behave in ways that may result in injury, harm, or death to persons on or around them; (2) the unpredictability of the equine's reaction to such things as sound, sudden movement, and familiar and unfamiliar objects, persons or other animals; (3) certain hazards such as surface and subsurface; (4) collisions with other equines, including but not limited to being kicked by one horse while riding another; (5) collisions with objects, including but not limited to the ground and objects on the ground, jumps, fences, buildings, farm implements, automobiles, tress, and other natural and unnatural objects located directly in or accessible to the areas in which equestrian activities occur; (6) the potential of another participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the animal or not acting within his or her own ability.

In consideration of the opportunity to participate in equestrian activities, or in consideration for being able to board my horse ✓ N/A at Paradis Farm, I HEREBY (1) RELEASE, WAIVE AND DISCHARGE FROM ALL LIABILITY, AND (2) COVENANT NOT TO SUE PARADIS FARM, ITS OWNERS, SUCCESSORS AND ASSIGNS, OPERATORS, EMPLOYEES AND AGENTS FOR ANY AND ALL LOSS OR DAMAGE AND ANY CLAIM OR DEMANDS ON ACCOUNT OF INJURY TO MYSELF OR MY PROPERTY OR RESULTING IN MY DEATH, WHETHER CAUSED BY THE NEGLIGENCE OF PARADIS FARM, ITS OWNERS AND EMPLOYEES, OR OTHERWISE WHILE I AM ON OR UPON THE PARADIS FARM PREMISES OR OTHERWISE PARTICIPATING IN EQUESTRIAN OR THER RELATED ACTIVITIES ASSOCIATED WITH PARADIS FARM.

I further understand and agree that Paradis Farm and its owners STRONGLY RECOMMEND THAT I NOT PARTICIPATE IN EQUESTRIAN ACTIVITIES UNLESS I HAVE MEDICAL INSURANCE SUFFICIENT TO COVER BOTH MINOR AND SERIOUS BODILY INJURIES, AND DISABILITY INSURANCE IF I AM EMPLOYED OR HAVE OTHER SIGNIFICANT RESPONSIBILITIES.
